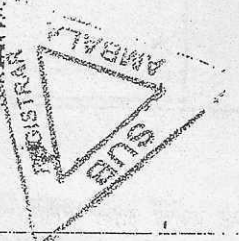

Amendment to Trust Deed

This amendment trust deed is made today, the 16th day of July 2018 by Shri Tarsem Kumar S/o Shri Inder Pal is resident of 55 - Model Town, Ambala City (hereinafter called the "settler").

Whereas the above said settler Sh. Tarsem Kumar had created a Trust, presently, known as Maharishi Markandeshwar University Trust (the Trust) , for educational purpose during 1993, which was duly registered with the Sub-Registrar, Ambala City vide registration No. 2242 dated 26.11.1993. Certain amendments in the said Trust deed were also made and the same were also registered with Sub Registrar, Ambala vide Registration No. 1759 dated 22.7.1997, Registration No. 11546 dated 20.1.2006, Registration no. 1780 dated 09-07-2007, Registration No. 2213 dated 06-08-2007 and finally vide registration No.3143 dated 26-08-2010.

University" to "Maharishi Markandeshwar" (Deemed to be University) by the notification of Ministry of HRD vide its notification No. F.9-65/2006-U.3(A) dated 11.11.2018 in pursuance of the directions of the Hon'ble Supreme Court judgment dated 03.11.2017 in Civil Appeals Nos. 17869-17870/2017 filed by Orissa Lift Irrigation Corp.Ltd vs Rabi Sankar Patro & Ors. Pursuant to the same, the Trust in its meeting held on 12-7-2018 has approved such change and the name of the Trust shall be amended to "Maharishi Markandeshwar Trust" with effect from 11-11-2018.

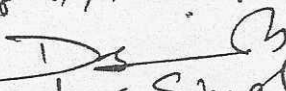
It is further declared that effect of meeting held on 15.6.2007 approving with effect from 12.6.2007, to bring the movable and immovable property of all the constituent institutions of Maharishi Markandeshwar (Deemed to be University), Mullana-Ambala under the legal ownership and total control of Maharishi Markandeshwar University shall remain unchanged and shall be read as Maharishi Markandeshwar (Deemed to be University).

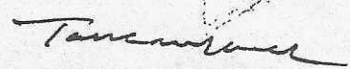
Further in the said meeting, it has been decided that the Memorandum of Association of the Trust be amended so as to incorporate the name of the Trust as, "Maharishi Markandeshwar Trust". It has also been decided that all future correspondence of the trust from the date of registration of this deed shall be made under the name "Maharishi Markandeshwar Trust".

That all other terms and conditions applicable to the present trust shall be governed by the earlier trust deed as detailed in above paras amended from time to time and shall remain operative and unchanged.
